

Guardian Defense Job Description

JOB TITLE: LEAD INSTRUCTOR

JOB TYPE: Independent Contractor

REPORTS TO: Vice President

SUPERVISES: None

POSITION DESCRIPTION:

The Lead Instructor's primary responsibility is to use the Guardian Defense threat response training model to provide practical solutions to civilians. They will be the primary speaker during lecture-based training and will lead the simulations in scenario-based training.

Location: Candidate should reside within 45 miles of zip code 33427.

Note: This is not a full-time position. This position is ideal for someone who is a recently retired law enforcement officer or someone who is looking for supplemental income to another position. This position does not offer consistent hours and instructors sign up for jobs as contracts become available. Candidate should be prepared and available to travel within the state of Florida and outside the state for a few days at a time.

PRIMARY DUTIES AND RESPONSIBILITIES:

- Advocate Guardian Defense's initiative of POLICY-TRAIN-DRILL when at work and when in the community
- Be primary speaker in lecture-based training courses
- Lead the practical and scenario-based exercises
- Facilitate the safety protocols of the scenario-based exercises and oversee assistant instructors
- View training schedule regularly and sign up for available jobs (at least one job per month if applicable)
- Keep regular communication with supervisor
- Retrieve equipment from assistant instructors after each training and return to supervisor
- Submit a brief report upon the completion of each job to supervisor
- Support and mentor new instructors

WORKING CONDITIONS:

Work is performed on location of each clients' place of business. The Lead Instructor may be asked to move and/or carry items of furniture or other objects; and may be subjected to loud noises, such as controlled explosions or the discharging of blank ammunition.
